Terms & Conditions

1. INTERPRETATION

1.1 Definitions. In these Supplementary Conditions, the following definitions apply:

Conditions: the terms and conditions set out in Andrews Sykes standard terms and conditions of supply available upon request or from www.sykes-pumps.com.

Contract: the contract between the Andrews Sykes and the Customer for the sale and purchase of the Eligible Goods in accordance with these Conditions and these Supplementary Conditions.

Discount: shall bear the meaning set out in clause 3.1. Eligible Goods: the 4" or 6" SUPER WISPASET pumps as set out in the Quotation.

Order: the Customer's order for the Eligible Goods, as set out in the Customer's written acceptance of an Andrews Sykes quotation.

Price: the sum stated in the Quotation as being the price of the Eligible Goods before any discount.

Scrappage Plant: the Customer's 4" or 6" Sykes pumps as set out in the Quotation.

Specification: any specification for the Eligible Goods, including any related plans and drawings, that is supplied to Andrews Sykes by the Customer, or produced by Andrews Sykes and agreed in writing by the Customer.

Supplementary Conditions: the terms and conditions set out in this document.

Warranties: the Customer's warranties as set out in clause 4.

1.2 Construction. In these Supplementary Conditions, the following rules apply:

1.2.1 Words defined in the Conditions shall bear the same meaning unless the context dictates otherwise.

1.2.2 Reference to a clause number shall be a reference to a clause in these Supplementary Conditions unless stated otherwise.

2. BASIS OF CONTRACT

2.1 The Conditions and these Supplementary Conditions apply to the Contract to the exclusion of any other terms that the Customer seeks to impose or incorporate, or which are implied by trade, custom, practice or course of dealing.

2.2 In the event of a conflict between the Conditions and these Supplementary Conditions, the latter shall prevail.

3. DISCOUNT

3.1 A Quotation shall set out the Price, together with the level of any applicable discount in respect of the Eligible Goods (Discount).

3.2 Entitlement to the Discount shall be conditional upon:

3.2.1 the Scrappage Plant being made available by the Customer for collection by the Supplier at the same place and time as delivery of the Goods;

3.2.2 the Warranties being true in all regards;

3.2.3 payment of the Price less the Discount being made to Andrews Sykes in accordance with clause 6.2; and

3.2.4 availability of the Eligible Goods in stock held by Andrews Sykes.

3.3 The Discount shall only apply in respect of the Eligible Goods and shall not apply to any other goods and services supplied by Andrews Sykes including any modification to the Eligible Goods to meet any Specification.

3.4 The Discount shall only be capable of set-off against the Price and there shall be no cash alternative.

4. WARRANTIES

4.1 The Customer warrants, represents and undertakes that:

4.1.1 the Scrappage Plant matches the description set out in the Quotation;

4.1.2 the Scrappage Plant is in working condition, determination of which shall be at the sole discretion of Andrews Sykes; and

4.1.3 the Customer has full and unencumbered title to the Scrappage Plant and can transfer the same to the Supplier free from any third party claim.

4.2 The Customer hereby agrees to indemnify keep indemnified and to hold harmless the Supplier from and against all loss, damages, costs and claims, howsoever arising, suffered or incurred as a result of a breach of the Warranties.

5. TITLE AND RISK

The title to and risk in the Scrappage Plant shall pass to Andrews Sykes on delivery to an Andrews Sykes premises.

6. PRICE AND PAYMENT

6.1 The price of the Eligible Goods shall be the Price less the Discount, both as set out in the Quotation, or, if no price is quoted, the price set out in the Andrews Sykes published price list in force as at the date of delivery.

6.2 The Price less the Discount is payable in accordance with clause 8.1 of the Conditions.

6.3 In the event of a breach of any of the conditions set out in clause 3.2.1 to 3.2.3 then the Customer's entitlement to the Discount shall cease and the Price shall be immediately due and payable in full.
